Gatekeepers of Governance – 21st and 22nd November, 2019

The sixth annual two day Summit on Corporate Governance, Gatekeepers of Governance, is being organised on 21st and 22nd November, 2019 in Mumbai, by Excellence Enablers, an initiative of the former Chairman of SEBI, Mr. M. Damodaran. Trident Hotel, Bandra Kurla Complex will be the venue of the Summit. The Summit comes at a time when policymakers, regulators, market participants, investors and others are absorbing and coming to terms with the shocks arising out of major governance lapses in

large entities.

On 21st November, the Summit will get off to a great start with Mr. Kumar Mangalam Birla in a conversation with Mr. M. Damodaran. That day will witness stimulating discussions, by experienced and expert panellists on the concept of a governance premium; the role, if any, of star fund managers in the Mutual Fund industry; the performance of Boards; the role of company secretaries as conscience keepers; and the response of auditors, Directors and management in challenging times.

On 22nd November, the first session will be a free-wheeling conversation on Corporate Governance between Ms. Kiran Mazumdar Shaw and Mr. R. Gopalakrishnan. Subsequent sessions will address the vexed question of related party transactions as well as the family business interface.
